Victim:

On 03/25/14 at about 0900 hrs, a phone call was received from . He wished to report the sexual assaults of victim and other young girls.

reported that told him that she was molested by Tyler Kost. He stated that reported the following to him:

Tyler met her at the Freddy's restaurant near Denny's in San Tan Valley. Tyler attempted to kiss her through the window of her vehicle. He then grabbed her breast and crotch. She attempted to fend him off. Tyler forced his way into her vehicle. She jumped out. Tyler chased her around their vehicles. After she left, Tyler threatened to tell lies about her to her parents and threatened to "beat her up".

Tyler has threatened to shoot her and every other girl who has turned down his sexual advances.

forwarded me screenshots of text messages between him and . In the messages, told that Tyler molested her and threatened to put a gun to her head. The messages were placed into property as evidence.

On 03/25/14 at about 1500 hrs, I returned : call. He reported the following:

told him that called her about 10 minutes after our initial conversation. relayed to her that Tyler had raped another girl the day before. He did not know the girl's name. stated that Tyler had threatened to shoot someone, but he did not know who that was.

He would review electronic communications and get back to me.

On 03/26/14 at about 1037 hrs, I received an email from . In the email were screenshots of text messages shared with . In them, tells that Tyler touched her. The messages were placed into property as evidence.

On 03/27/14 at about 1545 hrs, I received a phone call from . He reported that assault occurred sometime in February 2014.

I contacted Freddy's restaurant manager by phone. She reported that their surveillance system no longer contained footage of February.

I contacted Denny's restaurant manager . She reported that their surveillance system did not cover the area where the assault occurred.

On 03/28/14 at about 1253 hrs, emailed me screenshots of text messages he shared with and . In the texts, told that Tyler molested her and threatened to put a bullet in her head. Also in the texts, told that Tyler forced to do stuff with him.

On 03/30/14 at about 1924 hrs, emailed me a diagram that he created that showed where assault occurred. In the email, stated that was pretty sure that the assault occurred during the daytime on 02/16/14.

On 04/03/14 at about 1045 hrs, I conducted a forensic interview with regarding this case and a related sex offense under DR #140403141. reported that Tyler tried to touch . also stated that told her that Tyler did something to .

On 04/04/14 at about 0840 hrs, I conducted a forensic interview with regarding a related sex offense under DR #140404111. During the interview, reported that Tyler worked at Freddy's restaurant.

On 04/07/14 at about 1325, I conducted a recorded forensic interview with . She reported the following:

She was introduced to Tyler around August 2013 through who was dating him at the time. The two broke up around September 2011.

Tyler often left school with different girls in his vehicle. One of these girls was

was 16 at the time.

Tyler is currently dating 15 year-old freshman



told her that Tyler raped her on 03/20/14.

After hanging out with him only three times before, she messaged Tyler to meet her to talk at Freddy's restaurant at about 1500-1600 hrs on Sunday, 02/16/14.

Tyler approached her as she was still sitting in her vehicle. They began talking through her open driver door. Tyler put his face real close to hers. She turned her head and looked straight ahead because she thought he was going to try to do something. Tyler repeatedly told her to look at him, that he was not going to do anything to her. She kept telling him no.

Tyler grabbed her by the neck and tried to force her to kiss him. She put her hand in front of her mouth. Tyler inadvertently kissed her hand. She became upset. Tyler said, "I know you want to." She replied that she did not and reminded him that she had a boyfriend. Tyler stated that her boyfriend was 1,500 miles away and would never know. She told Tyler to back up because he was too close to her.

Tyler forced his way onto the driver seat where she was seated. This made her really uncomfortable. She climbed into the front passenger seat. Tyler grabbed her by the neck and tried to force her to kiss him a second time. She jumped out of the passenger door and began running around the vehicles parked in the area to get away from Tyler who was chasing after her.

She jumped back into her driver seat and shut the door. She tried to roll up her manual window, but Tyler reached the door before she could roll it all the way up. Tyler stuck his face and arm into the window. Tyler put his hand under her crotch between her legs. Tyler's hand was between her bottom and the car seat. She pushed his hand away. He then grabbed her breasts with his hand above her clothing. She pushed him away and told him to stop. She told him that she did not want to do that. Tyler kept telling her not to worry, that neither her boyfriend nor his girlfriend would ever find out about it. She pushed him away again and drove away.

Tyler called her minutes after she left. He told her that he knew where she lived. Tyler threatened to tell private things about her to everyone including her parents and the police. He threatened to

"destroy" her vehicle.

and told her that Tyler had threatened to shoot her and all the other girls that had rejected his sexual advances in the head. Tyler has never threatened her directly to assault or kill her.

During the interview, drew a map of where the assault occurred. It was placed into property as evidence.

On 04/10/14 at about 1531 hrs, I conducted a recorded phone interview with regarding a related sex offense under DR #140410090. During that interview, reported that she knew that Tyler touched .

Victim:

NARRATIVE:

On 04/03/14 at about 1045 hrs, a recorded forensic interview was conducted with Poston Butte High School student [REDACTED] regarding DR #140403141 and other related sex offenses involving suspect Tyler Kost. During the interview, [REDACTED] reported that student [REDACTED] told her that Tyler "did something" to [REDACTED].

On 04/04/14 at about 1200 hrs, I conducted a recorded forensic interview with [REDACTED]. She reported the following:

At the end of October 2012, Tyler messaged her on Facebook. He told her that she was pretty. They talked a couple times over the next few days at school. Tyler messaged her and asked her if she wanted to go to his residence and meet his mother. She agreed.

On 11/06/12, her mother dropped her off at Tyler's residence after school. She met Tyler's mother [REDACTED] and Tyler's [REDACTED] brother [REDACTED]. Tyler's mother left the residence to go to Fry's grocery store about 10 minutes after she arrived there. [REDACTED] remained at the residence with them.

Tyler invited her to go upstairs to watch a movie. She and Tyler went to the upstairs loft and sat on the couch. Tyler started "getting more in my space", "coming on strong", and "was all over me". Tyler continued to move closer to where she was sitting. He began kissing her. She felt awkward because they did not know each other very well. She told Tyler that she felt uncomfortable because this was their first time meeting outside of school. Tyler attempted to console her by stating that it was okay, that he was not going to hurt her, that it was meant to be, that they were not going to get caught, and that his mother was not going to be home soon.

Tyler held her down by the shoulder with his right hand and fondled her breasts and vagina over her clothing with his left hand. She squirmed around and pushed against Tyler's chest. This caused the hand that Tyler was using to hold her down to lose its grip on her shoulder. Tyler got off of her. He pulled on

her legs and pushed her shoulders down onto the couch. This put her in a reclining position.

Tyler laid on top of her. She told Tyler that she did not want to have sex with him and tried to push him off of her. Tyler began kissing her neck. Tyler produced a blanket and stated that they could use it to cover themselves and "do stuff". She told Tyler no and said that she did not want to do anything with him.

Tyler got off of her and began pulling off her pants. He tugged harder and harder on them. He pulled her pants and underwear down to her ankles. She told him that she did not want to do this with him. Tyler responded by saying that it was okay for her to feel that way and that it was meant to be. She did not know what to do. She considered hitting Tyler in an attempt to get away from him, but she was scared of him because of he was physically larger and stronger than her. She pushed against Tyler with all her strength, but was unable to move him. She told Tyler to get off of her, that she did not want to do this. Tyler ignored her and kept going.

walked up the stairs and turned into his bedroom. Tyler told her that did not see them.

She squeezed her legs together as tight as she could and anchored herself to prevent Tyler from assaulting her. Tyler overpowered her and forcibly pulled her legs apart. He started "fingering" her. By this she means that Tyler moved his fingers in and out of her vagina. The motion of Tyler's hand was "intense" and "ferocious". It was uncomfortable and caused her pain.

Tyler did not do what he did out of love. From the way he acted, Tyler appeared to be trying to get a "fix" to satisfy some sort of addiction. Tyler "just wanted the sex". During the entire incident, Tyler never removed his shirt. Tyler never lifted or removed her shirt.

Tyler began kissing her. She put her hands up around her face to deflect him. She was terrified and in shock.

Tyler pulled his erect penis through the hole of his boxer shorts and pant zipper. She noticed that Tyler's penis had a birthmark or discoloration on it. It was a dark pigmentation spot about the size of a silver dollar.

She tried locking her legs together a second time. Tyler forcibly pulled them apart again. She attempted to talk Tyler out of what he was doing. She told him that she did not feel comfortable and did not want to have sex with him. Tyler did not respond to her.

Tyler penetrated her vagina with his penis with hard and fast thrusts. This was uncomfortable and caused her pain. Tyler's assault tore the lower part of her vagina.

The assault lasted for only about 30 seconds before [redacted] walked in on them again. This scared Tyler. Tyler pulled his penis back into his pants. She stood up and pulled her pants up. [redacted] saw her naked buttocks. She knew that [redacted] saw her by the look he gave her.

Tyler suggested that they go downstairs. She told Tyler that she did not feel comfortable with what was going on. She told him that she wanted to stop and call her mom for a ride home.

Tyler picked her up and carried her down the stairs. She began to panic. She told Tyler that she did not want this and demanded that he put her down. Tyler stated that he did not want to put her down and joked about dropping her down the stairs.

Tyler laid her down on the carpeted dining room floor next to the china cabinet. He pulled her pants down to her ankles and tried to have sex with her again. She gave up and stopped resisting him. Tyler pulled his pants down to his ankles and penetrated her vagina with his penis.

Tyler's mother returned home. Tyler got off of her and pulled his pants up. She stood up and pulled her pants up. Tyler invited her to stay for dinner. She declined his offer and called her mother pick her up.

Tyler later told her that [redacted] reported to their mother that he saw her buttocks. Tyler told her that his mother instructed him to be more discrete when having sex in the future so [redacted] would be exposed to it.

She did not disclose Tyler's assault to her parents until just a few days before.

A few months following the assault, she tried to discuss the assault with Tyler. Tyler refused to talk with her about it and changed the subject.

Her mother did not trust Tyler. A couple months after the assault, her mother took her to a gynecologist. She was tested [REDACTED] and put on birth control. She also received a pelvic exam. Nothing exceptional was discovered during the exam as her vagina had healed on its own.

They considered the day that Tyler assaulted her as their first day dating. They broke up ten months later one week prior to fall break.

Tyler liked to have sex. She and Tyler had sex "a lot". Sometimes she wanted to have sex with Tyler. On other times, she did not. On at least five occasions at her home, Tyler would pressure her for sex. When she refused, Tyler would "push her down". She would try to leave. Tyler would grab her and pull her toward him. She would tell him "no" again. Tyler would sweet talk her and ask her manipulative questions such as, "Don't you love me?" She was afraid of Tyler because he had an aggressive side and had told her that, if a girl were to strike him, he would strike her back. She would then lie still and not resist him. Tyler would then sexually assault her. During these occasions, she would never verbally resist Tyler or tell him to stop. During the sex, she would be "more hostile" toward Tyler and be less engaged in the act. Sometimes she would tell him to hurry up, ask him if he was going to finish quickly, or ask him to stop. Tyler would respond stating that he was still "hard" and wanted to "keep going".

On 04/06/13, she attended prom with Tyler. During the dance, she commented on how she thought the autistic students looked cute together. Tyler grabbed her chin and turned her face toward him. Tyler told her that that night was about them and that he did not want her looking at anyone else. Tyler asked her if she wanted to ruin their night together. She told Tyler "fuck you," and walked outside into the parking lot.

She was standing next to the car. Tyler followed her outside and asked her, "What the fuck is your problem." She told him that she had affection for autistic children because [REDACTED]

Tyler got very close to her. She pushed him away. He coiled a fist back as though he was going to punch her. She confronted him and asked him if he really planned to assault her. He apologized to her.

She considered breaking up with him, but Tyler always manipulated her and convinced her to stay with him. Her mother [REDACTED] witnessed Tyler being manipulative to her. [REDACTED] always told her that Tyler was manipulating her and was no good for her.

She and her family returned from a vacation in Las Vegas in January 2013. Tyler tried to give her a dog that cost him \$250. She told Tyler that she could not keep the dog. Tyler took the dog to his residence. He lied to his parents, stating that he had found it on the side of the road. After they broke up, she sent a Facebook message to Tyler's parents informing them that Tyler had lied to them about the dog.

About every two weeks while they were dating, girls would warn her about Tyler attempting to start a relationship with them. They would send her screenshots of text messages of Tyler hitting on them and other girls and asking them to perform sexual acts on him. Tyler sent these messages to at least 10 girls while they were dating. When she confronted him, Tyler would accuse an ex-girlfriend of fabricating the messages in an attempt to sabotage their relationship. She did not keep these messages.

[REDACTED] was one of these girls that Tyler approached while she and Tyler were still dating. Tyler broke up with her two days later in order to pursue [REDACTED].

She and Tyler broke up after 10 months of dating a week before fall break.

Tyler is smart, manipulative, and a smooth talker. He is also obsessive and controlling. Tyler has an "aggressive side". Tyler believes that everyone else is wrong. That is how he was able to victimize so many people.

Tyler does not like the word "no". "If Tyler wants it, Tyler gets it now." While they were dating, Tyler would show up at her home every Saturday at 0700 hrs even after she told him to stop.

She believes that Tyler's mother is easily influenced by Tyler and that she would lie in order to protect Tyler from prosecution.

When asked, [REDACTED] stated that she would be willing to conduct a confrontation call with Tyler.

On 04/04/14 at about 1230 hrs, I contacted [REDACTED] mother [REDACTED] by phone. She consented to [REDACTED] participating in a confrontational call with Tyler. [REDACTED] arrived a short time later.

A confrontation call was conducted. Tyler would not engage [REDACTED] and ultimately disconnected. I instructed [REDACTED] to text Tyler. She and Tyler texted back and forth. In his messages, Tyler admitted to having consensual sex with [REDACTED], but denied any wrongdoing.

As we were engaged in the [REDACTED] call and texts, Poston Butte High School Assistant Principal [REDACTED] advised me that Tyler and his mother had just arrived at the school to meet with administrators.

Digital recordings of [REDACTED] interview and the confrontation call are attached to this report.

I provided [REDACTED] with her victim rights materials.

On 04/07/14 at about 1440 hrs, I conducted a recorded forensic interview with [REDACTED] regarding this case and DR #140403069. During the interview, [REDACTED] reported that she had been told by others that Tyler raped [REDACTED].

On 04/11/14 at about 1245 hrs, I contacted [REDACTED]. She stated that she received a final text message from Tyler. She showed me the messages. I photographed the messages. She stated that she would also forward them to me electronically.

On 04/16/14 at about 1105 hrs, I conducted a recorded forensic interview with [REDACTED] regarding this and a related sex offence under DR #140415136. During the interview, [REDACTED] reported that his girlfriend told him that [REDACTED] disclosed to her that Tyler gave [REDACTED] bruises on her arms and that [REDACTED] concealed the bruises by wearing long sleeved shirts.



**Victim:** ██████████

**NARRATIVE:**

On 04/04/14 at about 0800 hrs, I conducted a forensic interview with ██████████ regarding a related sex offense under DR #140410089. During that interview, ██████████ suggested that I interview suspect Tyler Kost's ex-girlfriend ██████████. She stated that ██████████ was impregnated by Tyler at the age of 15 and that they the two were adversaries in a court matter.

On 04/11/14 at about 1057 hrs, I conducted a forensic interview with ██████████ brother ██████████ regarding this case and DR #140410093. He reported the following:

He was once friends with Tyler. They met during a weight lifting class when he was a freshman. He suggested to Tyler that he date ██████████.

Tyler began dating ██████████ in September of 2013. While dating, Tyler purchased ██████████ a husky dog. After they broke up, Tyler attempted to take the dog away from her.

Tyler went with ██████████ to her homecoming dance. He has heard several reports of Tyler molesting girls. One of these girls was ██████████ ██████████ told him about an incident in which Tyler drove her to a remote area of desert, locked the vehicle doors, and refused to let her out or take her home unless she had sex with him. When she refused, Tyler drove her to his driveway where he did the same thing again.

██████████ told him that Tyler has blackmailed her.

Tyler once threatened him in a text message to put a gun to his head.

██████████ and their mother ██████████ told him that Tyler forced ██████████ to "do stuff" during their homecoming dance and ██████████ became pregnant at the age of fifteen.

██████████ had an ██████████ in January. Tyler was not initially aware that ██████████ had the ██████████.

Tyler attempted to file an Order of Protection against him and ██████████. The request was denied during a hearing in the Apache Junction JP Court.

On 04/17/14 at about 0830 hrs, I conducted a recorded forensic interview with [REDACTED]. She reported the following:

She first met Tyler about two years ago. He was a friend of [REDACTED]. Her and Tyler's first kiss was in July of 2011. They began dating on 09/26/13.

On 09/21/13 she and Tyler were tongue kissing. He asked her how long it would be before he could have some fun. She asked him what he meant. Tyler replied, "You know. Adult fun." He then winked at her.

On the weekends, she would sometimes sleep-over at her friend [REDACTED] residence. On 3-4 occasions, she and [REDACTED] would wake up in the morning to Tyler being in the bedroom with them. She did not know how Tyler got there, but assumed that [REDACTED] father let him in. After that, her father began turning Tyler away when he showed up because he became wary of by Tyler's behavior.

Tyler would tap on her breasts over her clothing and jokingly refer to them as "bongos". He began doing this more frequently as they dated. Her younger brother [REDACTED] witnessed this.

On 09/28/14 she attended her homecoming dance with Tyler. As he drove her back home, Tyler ran his hand up her thigh. She slapped his hand and told him to stop. Tyler responded by laughing at her. Tyler was driving a white Dodge Charger.

On 10/12/13 or 10/19/13 she attended Tyler's homecoming dance with Tyler. Tyler was acting strange. Tyler wanted to leave the dance early. He drove her home. Once there, he asked her to go for a walk with him. They ended up at a park near her home. Tyler hugged her. When he did, he squeezed her buttocks and whispered in her ear, "I'm going to fuck the shit out of you." She pushed away from him. Tyler grabbed her and said, "C'mon, let's do it." He pushed her against a wall and pulled her arms behind her back. He crossed her wrists behind her back and held them together with one hand. He squeezed her left breast with his free hand. Tyler "stiff armed" her, causing her to bend forward. He used his free hand to move her underwear to the side. Tyler penetrated her vagina with his penis from behind. He asked her, "Does that feel good, baby?" She told him no and yelled at him to get off of her. She attempted

to get away from Tyler, but couldn't because of the way he was restraining her. He told her that he was almost finished. She yelled at him that he was finished and demanded that he let her go. Tyler became startled when a vehicle drove by. He released his grip on her and pulled up his pants.

She ran to her home crying. She felt sick. She entered her house and ran upstairs to her bedroom. Her mother, who was in the living room, asked her what was wrong. Tyler followed her into the house. She changed her clothes and returned down stairs. She screamed at Tyler to leave her house. Tyler left. She disclosed what happened to her mother.

She has since washed her dress. She believes that her dog chewed up her underwear.

She became pregnant. She knows that Tyler was the father. She had sex only once before. It was with her previous boyfriend [REDACTED] and it occurred in October 2011.

Tyler was excited to be a father. He told her that he was "never more sure" of anything. When he found out that she was considering an abortion, Tyler became very upset and angry. He threatened her stating that, if she broke up with him or aborted their baby, he would destroy her reputation. He threatened to tell everyone that she had an abortion. He stated that everyone was going to know that she was a "whore" and would find out what kind of person she really was.

She and Tyler did most of their communicating electronically. They used applications such as text messaging, Facebook, Snap Chat, KIK Messenger, and Instagram.

Tyler messaged some people about raping her. She knows that her current boyfriend [REDACTED] was one of these people. Her friend [REDACTED] may have also received the message.

Tyler texted an apology to her mother.

She was 15 years old and Tyler was 17 at time he assaulted her.

[REDACTED] showed me a photograph of her and Tyler that was taken during his homecoming. I photographed it. It is attached to this report.

On 04/17/14 at about 1020 hrs, I contacted [REDACTED] by phone. I updated her on the investigation and conducted an interview with her. [REDACTED] reported the following:

She recalled the evening of Tyler's homecoming dance. She was in the living room when [REDACTED] ran inside crying. [REDACTED] said that she felt sick. Tyler followed her into the house. [REDACTED] ran upstairs, changed her clothes, returned downstairs, and yelled at Tyler to get out of the house. She told Tyler to leave and said that she would talk with [REDACTED] and have her call him later. Tyler left.

After Tyler left, [REDACTED] disclosed what happened. She misunderstood the seriousness of the situation. [REDACTED] made a bad decision before by having sex with a previous boyfriend. She assumed that this was the same sort of situation.

[REDACTED] became pregnant. She accompanied [REDACTED] to her ultrasound on 12/31/13 and [REDACTED] on 01/04/14. These appointments were at the Planned Parenthood in [REDACTED]

[REDACTED] disclosed the assault to a counselor at Planned Parenthood. The counselor intentionally miscoded the assault as a consensual encounter. The counselor told them that they did not want the hassle of having to report the assault to law enforcement as they were a mandatory reporter.

They did not notify Tyler of [REDACTED]

Tyler sent her and her mother a message apologizing, stating that "I'm sorry this happened." Tyler told them of how he planned to take care of [REDACTED] and their baby. She responded back to him stating that [REDACTED] was not pregnant. She would forward these messages to me.

Tyler filed an Order of Protection request against [REDACTED] and [REDACTED]. During a hearing at the Apache Junction JP Court, the Judge refused Tyler's request.

**Victim:** [REDACTED]

**NARRATIVE:**

On 03/25/14 at about 0900 hrs, I received a phone call from [REDACTED]. He reported that several young female Poston Butte students had been sexually assaulted by suspect Tyler Kost. [REDACTED] stated that [REDACTED] was one of these students.

On 03/25/14 at about 1322 hrs, I left phone messages for [REDACTED] father [REDACTED] and mother [REDACTED]. [REDACTED] returned my call a short time later. I informed [REDACTED] of the alleged assault against [REDACTED]. I asked [REDACTED] to speak with [REDACTED] about the allegation and to contact me the next day.

I spoke with [REDACTED] moments later when she returned my call. She reported the following:

[REDACTED] went to a school dance with Tyler about a year ago.

Other students have told her and [REDACTED] that Tyler has been threatening people. These students asked them for Tyler's home address. She did not give it to them because she believed that the students were planning some sort of retribution against Tyler.

On 03/28/14 at about 1253 hrs, [REDACTED] forwarded me screen shots of text messages he shared with [REDACTED]. In those texts, [REDACTED] states that Tyler forced himself on [REDACTED] and "fingered" her. Copies of these messages were placed into property as evidence.

On 04/03/14 at about 1045 hrs, I conducted a recorded forensic interview with [REDACTED]. She reported the following:

Tyler preys on younger girls.

In February of 2013, she and Tyler were in the loft of Tyler's residence. They were lying on the floor watching television. They kissed twice on the lips. Tyler reached under her pants and underwear and touched the outside of her vagina with his bare hand. She pushed Tyler away from her and ran out of Tyler's residence. She called [REDACTED] and asked him to pick her up. While she was standing outside, Tyler yelled at

her and threatened her by telling her to sleep with one eye open because he knew where she lived. [REDACTED] picked her up a short time later.

Tyler's house is in [REDACTED]. It is on the right hand side of the road past the elementary school.

Tyler tried to touch student [REDACTED]. Tyler blackmailed student [REDACTED] by threatening to put her in jail and disclose information to her parents.

[REDACTED] told her that Tyler raped student [REDACTED].

The allegations involving [REDACTED], [REDACTED] and [REDACTED] were investigated under DR's 140403069, 140410093, and 140410094 respectively.

On 04/10/14 at about 1531 hrs, I conducted a forensic interview with student [REDACTED]. [REDACTED] reported that Tyler attempted to have sex with a girl named [REDACTED]. She did not know [REDACTED] last name.

04/11/14 at 1320 hrs, I conducted an interview with [REDACTED]. She reported the following:

During their 5<sup>th</sup> hour English class together, [REDACTED] told her that Tyler tried to force her to have sex with him. [REDACTED] told her that she had to hit or punch Tyler to get him off of her. [REDACTED] told her that Tyler punched her back.

On 04/18/14 at about 1200 hrs, I contacted [REDACTED] by phone. He reported the following:

Based on his parental instincts, he neither liked nor trusted Tyler. He thought Tyler was sly. He and [REDACTED] had warned [REDACTED] about Tyler.

One of [REDACTED] girlfriends reached out to him, [REDACTED], and [REDACTED]. The girl warned them about Tyler. He will do research in order to determine [REDACTED] friend's name and the date she warned them about Tyler.

He picked up [REDACTED] from Tyler's residence on only two occasions. He will attempt to determine those dates.

He and [REDACTED] will research [REDACTED] electronic communications in an attempt to recover any correspondence between [REDACTED] and Tyler.

He will contact me with the results of his efforts.

In February 2013, [REDACTED] was 15 years old and Tyler was 17 years old.

Victim: [REDACTED]

NARRATIVE:

On 04/01/14 at about 1457 hrs, I received an email from [REDACTED] regarding a related sex offence under DR #140403069. [REDACTED] reported that his daughter [REDACTED] told him that victim [REDACTED] was raped by 18 year-old suspect Tyler Kost. [REDACTED] told him that [REDACTED] moved to [REDACTED] a month ago.

On 04/03/14 at about 1045 hrs, I met with Poston Butte High School Assistant Principal [REDACTED]. He stated that [REDACTED] unenrolled from school on 03/07/14

On 04/03/14 at about 1100 hrs, I conducted a forensic interview with [REDACTED] regarding this case and a related sex offense under DR #140403141. [REDACTED] stated that [REDACTED] told her that Tyler had raped both her and [REDACTED].

On 04/07/14 at about 1400 hrs, I conducted a forensic interview with [REDACTED]. She reported that [REDACTED] told her in a text message that Tyler had picked her up following a play rehearsal at Poston Butte. She stated that [REDACTED] told her that Tyler forced her down and raped her. [REDACTED] reported that she kept [REDACTED] text messages and that she would get them to me.

On 04/10/14 at about 1405 hrs, I contacted [REDACTED] mother [REDACTED] by phone. [REDACTED] reported the following:

[REDACTED] disclosed Tyler's assault on her. [REDACTED] told her that Tyler violated her when he was driving her home.

Tyler later texted [REDACTED] from a friend's phone. Tyler bragged to [REDACTED] about raping her and boasted that he "finished inside her." She has a screen shot of Tyler's texts. She will forward them to me.

[REDACTED] was traumatized by the assault. [REDACTED] is now in counseling to deal with her grief and depression.

On 04/10/14 at about 1531 hrs, I conducted a phone interview with [REDACTED] regarding this case and another



related sex offence under DR #140410090. [REDACTED] reported the following:

[REDACTED] told her that she had sex with Tyler. She told her that she told Tyler "no", but he kept going.

[REDACTED] forwarded Tyler's text messages about the rape to her. In the texts, Tyler called [REDACTED] a "whore". He also stated that he liked touching her and that he would do it again. After reading the messages, she recommended to [REDACTED] that she block Tyler's number.

I spoke with [REDACTED] mother. She stated that [REDACTED] moved to [REDACTED] out of fear because Tyler threatened her.

On 04/11/14 at about 1210 hrs, I spoke with [REDACTED] grandmother by phone. She reported the following:

[REDACTED] was afraid to talk with me.

[REDACTED] took a pregnancy test. The results were negative.

[REDACTED] moved to [REDACTED] as a result of what Tyler did to her.

On 04/11/14 at about 1320 hrs, I conducted a recorded interview with [REDACTED] by phone. She reported the following:

Tyler molested [REDACTED]. [REDACTED] texted her and told her that Tyler molested her in the parking lot of Freddy's restaurant that day. This incident occurred around February 2014.

Tyler assaulted [REDACTED]. During their 5<sup>th</sup> hour English class, [REDACTED] told her that Tyler initiated sex with her, but she did not want to. She hit or punched him off of her. [REDACTED] said that Tyler hit her back.

Tyler harassed [REDACTED] on Facebook. He also messaged [REDACTED] mother stating that [REDACTED] was sending nude photos to guys, that she was a "ho", and that she was pregnant.

Tyler raped her.

In the beginning of March of 2014, [REDACTED] introduced her to Tyler. She and Tyler hung out together for a few weeks. They communicated electronically through applications such as Snapchat. During this time, Tyler kissed her 2-3 times. This made her uncomfortable because they did not know each

other very well. She did not say anything to him about this. He once tried to open-mouth kiss her. She pushed him away and walked away. After that, she avoided him. She would take different routes in the school hallways and would skip school entirely to avoid him.

One day after school, Tyler did not have baseball practice. He drove her to his house. She followed Tyler into her bedroom. Tyler took off his shoes. Inside her head, a voice told her to leave. When she turned around to leave, Tyler grabbed her by the arm, picked her up off the ground, and threw her on his bed. She told him "no", told him to stop, and tried to get up off the bed. Tyler pushed her down. Tyler tried to take off her clothes. He told her, "Trust me." She was in the middle of the bed. Her legs were hanging off the end of the bed. Tyler lifted her shirt. She pulled it back down. Tyler unbuttoned and pulled down her pants and underwear. She told him, "I don't want to." Tyler kept going. She pushed him in the chest to get him off of her and again told her to stop. Tyler replied that he did not want to stop. He laid his full body weight on her and said, "Baby, trust me."

Tyler held her body down by pushing his hands onto her shoulders. He lifted her legs to her chest and "shoved his dick" into her vagina. Tyler penetrated her until he ejaculated. While he assaulted her, Tyler pushed her shirt up, reached under her bra, and squeezed her breasts forcefully causing her pain. She moved her head around to avoid being kissed by Tyler. Tyler sucked on her neck. After finishing, Tyler got off of her. She grabbed her clothes and ran into the bathroom. Tyler did not use a condom. She called her mother to pick her up.

Sometime later, Tyler texted her stating, "I busted in you, by the way," and "you wanted it." She has since gotten a new phone and cannot access the messages as she closed her KIK Messenger account when she switched phones.

She saw Tyler at school two days later. Tyler acted as though nothing had ever happened.

On Snapchat, she messaged a girl that Tyler was attempting to get with. She warned the girl about Tyler. Tyler used the girl's phone to message her back. Tyler made fun of her body parts, told her to shut up, called her a "whore", and said that she had

"a nasty ass". Tyler told her to "close her legs" and that he "busted" inside of her.

As a result of what Tyler did, she moved to Texas, she no longer eats, she has thoughts of suicide, and self harms herself by cutting her arms.

She hopes that Tyler spends the rest of his life behind bars, so that he can no longer hurt anyone else like he did to her.

Even though her home pregnancy test was negative, she plans on visiting her doctor to have another one and check for sexually transmitted diseases.

On 04/17/14 at about 1300 hrs, I conducted a forensic interview with ██████████ regarding this case and related sex offense DR #140415118. ██████████ reported the following:

Tyler used her phone to send harassing texts to ██████████. Tyler deleted his comments before he returned her phone to her. ██████████ later told her about the content of Tyler's messages. ██████████ told her that Tyler said ugly things to her such as "close your legs" and "go kill yourself". She will attempt to recover the messages and forward them to me.

██████████ mentioned Tyler using her phone to send ██████████ these messages in a written student report. A copy her report is filed under DR #140415118.

**Victim:** [REDACTED]

NARRATIVE: On 4-30-14 a voice mail was received from a subject identified only as [REDACTED] who advised that she had information relevant to the ongoing investigations into Tyler Kost. I contacted [REDACTED] back at the phone number provided and made contact with a subject identified as [REDACTED] [REDACTED] advised that she had previously lived in the San Tan Valley area, and gone to Poston Butte High School. [REDACTED] reported that she had dated Tyler for approximately 7 days, on or about October 9, 2012. [REDACTED] reported that, based upon her birthday, she was approximately 16 years of age at the time that she was involved with Tyler. She stated that she knew Tyler because they were in English class together. [REDACTED] reported that she had since moved out of state, later reporting that she currently resides in [REDACTED]

[REDACTED] reported that during the course of her involvement with Tyler, and the cause of the end of her relationship, Tyler sexually assaulted her. I asked [REDACTED] to explain and she stated that on one occasion Tyler had come to her home, at [REDACTED] in San Tan Valley, when he knew that her parents would not be present. She stated that while sitting on the couch, Tyler began attempting to remove her clothing. She stated that she told Tyler repeatedly "no" and to stop what he was doing, but he persisted. During the course of the interview I asked whether Tyler made any statements while this was going on and she indicated that he seemed to ignore her protests, and only stated that it would "be ok". [REDACTED] stated that despite her protests and physical attempts to stop Tyler, he held her wrists down and took off her clothes. She then stated that Tyler began to "go down there". I asked for clarification and it was determined that Tyler began to perform oral contact with her vagina. I asked whether Tyler was successful and she indicated that that he was. For additional clarification, I asked whether Tyler penetrated her vagina, and she indicated that Tyler vaginally penetrated her with his fingers and mouth. [REDACTED] stated that Tyler's clothes were on during the encounter, and that at no time was his penis exposed, and he did not penetrate her vagina with his penis.

[REDACTED] advised that while he was using his mouth on her vagina, she was able to escape, and she ran to a bathroom. Tyler pursued her to the bathroom, and she indicated that he grabbed her from behind. [REDACTED] then stated that he "hugged" her. [REDACTED] described this as her back against his chest. She described that his arms were wrapped around her chest, and that his hands were on her breasts. She stated that his hands rested on her breasts, with no movement as if he was "cherishing" the moment. [REDACTED] stated that she was able to push Tyler from the bathroom, and lock the door. She got redressed and told him that her mom was going to be home soon, so he left. [REDACTED] stated that after that he was "ugly" to her, making derogatory comments to her on Facebook and other areas, and talking badly about her to friends and other classmates. [REDACTED] stated that he made comments about her weight and other personal attacks against her. [REDACTED] stated that when she broke up with Tyler, over this incident, she told him that

"no means no" and repeated her objections to what he had done and reiterated her objections to the actions she had made at the time.

██████████ stated that she had told two friends about this encounter, ██████████ and ██████████. ██████████ was able to provide telephone numbers for both friends, and attempts to contact will be made. ██████████ stated that she was not aware of the current investigations going on with Tyler until her mother, who lives in Maricopa County, forwarded the press release to her. ██████████ stated that she then shared the article on her Facebook page. This prompted contact from ██████████. ██████████ stated that she knew ██████████ from when she lived in Arizona, but had not had contact with him recently. When she shared the article, he contacted her and urged her to contact the Sheriff's Office if she had any information, but stated that she had, by that point, already called the Sheriff's Office to make the report. ██████████ was able to assist me in locating her Facebook page, and I observed that she commented on the press release by stating, "Tyler Kost didn't you learn that no means no. I told you over and over!! Sick perv tried to get in my pants but I kicked him out of my home and dumped him because he didn't know the word no!! I'm sorry to anyone who was assaulted by this poor excuse of a man and I'm sorry I didn't say anything sooner. It was over a year ago you tried to get in my pants, thought it was just a phase he was going through, but unfortunately it wasn't. "

Based upon the above information it is believed that Tyler violated ARS 13-1406 by intentionally and knowingly engaging in oral sexual contact without consent.

On 5-1-14 I contacted ██████████ again and asked about the messages that occurred after the sexual assault. She stated that some of the messaging occurred on her phone, and some on her Facebook. She stated that she no longer has the phone, but will check with her mother to see if the equipment is still available. She stated that the phone number she is currently using is that same number the messages would have been sent to. In addition, I received information from Poston Butte that confirms that ██████████ and Tyler shared an English class until November of 2012. I asked ██████████ if she moved as a result of the incident with Tyler, or some other reason. She stated that it was a combination, but because she shared the class with Tyler, she was assigned to a group project with Tyler, and other people in the class were talking about her involvement with Tyler, she felt safest in moving to ██████████.

**Victim:** [REDACTED]

On 4-30-14 a phone call was received from a subject who identified herself as [REDACTED] [REDACTED] was crying and stated that she had been "raped" by Tyler Kost. She stated that she had previously reported this to her biological mother, but her father and step-mother were not aware. She stated that at the time of the call she was located in Mesa, but lived in both [REDACTED] as a part of the joint-custody arrangement between parents. [REDACTED] stated that she still goes to Poston Butte. Based upon her emotional state, it was determined that an interview would be conducted on 5-01 at the high school.

After talking to [REDACTED] I returned a voice mail from [REDACTED] It was learned upon contact that [REDACTED] is [REDACTED] mother, and that she had left the voicemail before [REDACTED] called me, but she had since learned of my conversation with her daughter. [REDACTED] confirmed that she had been told by [REDACTED] about the incident. She stated that this originally occurred in April or May of 2011. She stated that she remembered it was during baseball season, and likely after Easter, of 2011, but before [REDACTED] 15th birthday in July. [REDACTED] stated that at the time of the initial disclosure, [REDACTED] reported it as if it had happened to a friend, but when [REDACTED] confirmed that the actions reported were rape, and a crime, [REDACTED] confided that she had been the victim. [REDACTED] stated that she asked [REDACTED] at the time what she wanted to do about it, and [REDACTED] did not want to report it. Now that she was learning that there have been additional people who were also attacked by Tyler, [REDACTED] was very upset and reliving the trauma. [REDACTED] was asked about physical injuries as a result of the incident, and she stated that other than it "taking her virginity" there had been no injuries. I confirmed that there had been no pregnancy or STI as a result. I asked [REDACTED] about where the incident occurred, whether it was at the [REDACTED] locations, and she reported that to her knowledge it had occurred at Tyler's house. No additional details were asked of [REDACTED]

ON 5-1 I RESPONDED TO THE POSTON BUTTE HIGH SCHOOL TO INTERVIEW [REDACTED] AN AUDIO RECORDED INTERVIEW WAS CONDUCTED, AND A COPY OF THE INTERVIEW HAS BEEN ATTACHED TO THIS REPORT. THE FOLLOWING IS A SUMMARY OF THE INTERVIEW CONDUCTED, FOR SPECIFIC INFORMATION, REFER TO THE AUDIO.

[REDACTED] STATED THAT DURING HER FRESHMAN YEAR, SHE TRANSFERRED FROM APACHE JUNCTION HIGH SCHOOL TO POSTON BUTTE. SHE STATED THAT THIS OCCURRED OVER CHRISTMAS BREAK, BEGINNING HER TIME AT POSTON AT THE BEGINNING OF 2011. AT THAT TIME SHE WAS 14 YEARS OF AGE, NOT TURNING 15 UNTIL July 2011. [REDACTED] STATED THAT SHE WAS IN A CLASS WITH TYLER, POSSIBLY MATH, AND THEY WOULD TALK BACK AND FORTH ON TEXT. SHE STATED THAT SOME TIME DURING BASEBALL SEASON, POSSIBLY IN April OF 2011, TYLER INVITED HER TO HIS HOUSE. SHE AGREED AND WHEN SHE GOT THERE SHE NOTED THAT

TYLER'S DAD AND AND YOUNGER BROTHER WERE THERE. SHE STATED THAT THEY HUNG OUT WITH HIS BROTHER A LITTLE BIT IN THE GAME ROOM, BUT TYLER ASKED HER TO GO INTO HIS ROOM. SHE STATED THAT THEY WENT TO THE FAR SIDE OF HIS BED, WHERE THEY WOULD BE LESS VISIBLE FROM THE DOORWAY. ██████ STATED THAT DURING THIS FIRST TIME IN THE BEDROOM, TYLER ATTEMPTED TO "GROPE" HER, RUNNING HIS HANDS ON HER LEGS AND STOMACH. SHE STATED THAT SHE REPEATEDLY TOLD HIM "NO" AND TO STOP AND SHE LEFT THE ROOM AND WENT INTO THE GAME ROOM WITH TYLER'S BROTHER. TYLER EVENTUALLY TOOK HER BY THE WRIST AND BROUGHT HER BACK INTO HIS ROOM, THIS TIME HAVING HER SIT ON THE FLOOR ON THE FAR SIDE OF THE BED, WHERE VISIBILITY TO THE DOORWAY WOULD IMPAIRED. SHE STATED THAT SHE WAS SITTING AND HE BEGAN TRYING TO MOVE HER CLOTHING. ██████ COULD NOT REMEMBER WHETHER SHE WAS WEARING A SKIRT OR LOOSE SHORTS. TYLER SHE BELIEVED WAS WEARING BASKETBALL STYLE SHORTS. ██████ STATED THAT HE REMOVED HIS PENIS FROM HIS SHORTS, AND BEGAN ATTEMPTING TO INSERT HIS PENIS INTO HER VAGINA. SHE STATED THAT SHE FELT PAIN FROM THE PENETRATION, AND SHE TOLD HIM TO STOP AND TOLD HIM THAT IT HURT. TYLER RESPONDED THAT IT WAS BECAUSE SHE WAS A VIRGIN AND THAT IT WOULD TAKE A FEW TIMES. ██████ STATED THAT SHE WAS UNSURE WHETHER HIS PENIS FULLY PENETRATED HER VAGINAL CAVITY, BUT SHE KNEW THAT IT PENETRATED HER LABIA. ██████ REPORTED THAT SHE KNEW TYLER DID NOT PUT ON A CONDOM, BUT SHE WAS NOT SURE WHETHER HE EJACULATED. SHE WAS ALSO UNSURE WHETHER SHE HAD ANY DISCHARGE FROM HER VAGINA. ██████ STATED THAT SHE WAS ABLE TO GET TYLER TO STOP AND GET AWAY TO THE PLAY ROOM, WHERE SHE TEXTED HER MOM TO COME PICK HER UP EARLY. SHE TRIED TO STAY IN THE ROOM WHERE TYLER'S BROTHER WAS LOCATED, BUT HE EVENTUALLY LED HER BACK INTO THE BEDROOM ON TWO ADDITIONAL OCCASIONS. ██████ REPORTED THAT ON EACH OF THE SUBSEQUENT OCCASIONS HE WOULD PLACE HER ON THE FAR SIDE OF THE BED AND ATTEMPT TO PENETRATE HER VAGINA WITH HIS PENIS, CAUSING HER PAIN. EACH TIME SHE WAS ABLE TO GET AWAY, AND ON THE LAST TIME SHE WENT INTO THE BATHROOM. AFTER THE LAST TIME, THE FOURTH IN THE BEDROOM, THE THIRD WITH VAGINAL PENETRATION, HER MOM ARRIVED AND SHE LEFT THE HOUSE.

██████ STATED THAT SHE DID NOT DO ANYTHING WITH HER MOUTH OR HANDS. SHE STATED THAT TYLER DID NOT DO ANYTHING WITH HIS MOUTH, BUT GROPED HER BREASTS WITH HIS HANDS. ██████ STATED THAT AFTERWARD HE ASKED HER NOT TO TELL ANYONE ABOUT THE INCIDENT, AND SHE ASSUMED THAT SINCE SHE WAS EMBARRASSED ABOUT THE INCIDENT, THAT HE WAS TOO. SHE INDICATED THAT NO THREATS WERE ISSUED. AFTER THE INCIDENT SHE DID NOT HAVE ANY ADDITIONAL PHYSICAL CONTACT WITH TYLER, AND ONLY SAW HIM IN

CLASS. ██████ REPORTED THAT AT THE TIME SHE FELT PARTIALLY RESPONSIBLE FOR THE INCIDENT, AS SHE WILLINGLY WENT TO HIS HOUSE. ██████ STATES THAT NOW SHE HAS TROUBLE TRUSTING PEOPLE, SHE HAS HAD TROUBLE GETTING INTO ANY TYPE OF RELATIONSHIPS WITH ANYONE, AND THAT SHE HAS SIGNIFICANT FEARS OF BEING ALONE. ██████ STATED THAT SHE HAD SPOKEN ABOUT THE INCIDENT WITH A FRIEND, ██████, AT THE TIME, AND CONTACT INFORMATION WAS PROVIDED FOR FOLLOW UP. SHE STATED THAT AFTER THE PRESS RELEASE CAME OUT SHE SPOKE TO HER FRIEND ██████, BUT ONLY ADMITTED TO BEING A VICTIM, WITHOUT PROVIDING DETAIL. ██████ STATED THAT TO HER KNOWLEDGE SHE DOES NOT KNOW ANY OF THE OTHER PEOPLE WHO HAVE MADE ALLEGATIONS. SHE STATED THAT SHE HAS NOT SPOKEN TO ANYONE CLAIMING TO BE A VICTIM, AND HAS HAD NO CONTACT, AND DOES NOT KNOW, ██████

BASED UPON THE ABOVE INFORMATION, IT IS BELIEVED THAT TYLER KNOWINGLY AND INTENTIONALLY ENGAGED IN SEXUAL INTERCOURSE ON THREE OCCASIONS ON A SINGLE DATE BETWEEN January AND June OF 2011, WHILE ██████ WAS 14 YEARS OF AGE, AND WITHOUT HER CONSENT. FOR THIS REASON, A CHARGING REVIEW IS BEING SUBMITTED TO THE COUNTY ATTORNEYS OFFICE FOR CHARGES OF SEXUAL ASSAULT, WITH DCAC ENHANCEMENT, UNDER ARS 13-1406 AND 13-705, SEX CONDUCT WITH A MINOR, UNDER ARS 13-1405/ 13-705 AND MOLESTATION OF A CHILD, UNDER ARS 13-1410/ 13-705.



**Victim:** [REDACTED]

On 04/03/14 at about 1040 hrs, I conducted a recorded forensic interview with [REDACTED] regarding a related sex offense under DR #140410090. [REDACTED] provided me with the names of two girls that 18 year old suspect Tyler Kost has sexually assaulted. One of these girls was 15 year old victim [REDACTED]. [REDACTED] reported that Kost had consensual sex with [REDACTED] one time and non-consensual sex with her one time.

On 04/29/14 at approximately 1619 hours, a Forensic interview was conducted with [REDACTED] by [REDACTED] at the Pinal County Family Advocacy Center Located in Eloy.

Prior to the forensic interview myself and [REDACTED] met with [REDACTED] the biological mother of [REDACTED] in the conference room of the center. The contact was audibly recorded (04/29/2014 at 1600 HOURS) and attached for review. The following is a summary of the conversation, for specific details or further information please refer to the attached recording.

The contact begins with [REDACTED] advising that she is simply attempting to get back ground of the family prior to speaking with [REDACTED]. Questions such as names, primary language, siblings and custody are asked and answered. These routine questions continue until the question form is complete.

[REDACTED] asks [REDACTED] what she had informed [REDACTED] about coming to the center today. [REDACTED] responds, that [REDACTED] had actually informed her of what the reasoning of the visit. [REDACTED] continued that [REDACTED] had informed her that a few weeks ago a boy later identified as Tyler Kost had forced her to have sex with him. [REDACTED] continues that [REDACTED] tried to say, "No" and push him away, when she did he punched heR in the stomach. [REDACTED] stated that the incident was described to her as taking place in Kost's residence

[REDACTED] goes on to say that she has noticed a changing in [REDACTED] behavior as of the last weeks. [REDACTED] has been showing signs of depression and making irregular comments on her Facebook account.

I asked [REDACTED] if she was aware of any other relationships in which [REDACTED] was sexually active. [REDACTED] advised that she was aware of only one other relationship in which [REDACTED] had intercourse.

[REDACTED] continues that [REDACTED] is very strong willed. After the incident, [REDACTED] had informed Kost's current girlfriend (unidentified) of their relationship in an attempt to forewarn her of his actions.

[REDACTED] continues to state that she was informed the assault had occurred in March immediately after spring break.

After receiving [REDACTED] statements both [REDACTED] and I had left the conference room while [REDACTED] was given the opportunity to speak with Pinal County Attorney's Office Victims Services.

On 04/29/14 at approximately 1619 hours the forensic interview with [REDACTED] was conducted. The following is a summary of the interview. For specific details or further information please refer to the attached / video recording and the interviewer's supplemental report.

[REDACTED] is a 15 year old female who provided information of a Sexual Assault by an adult male identified as Tyler Kost. [REDACTED] provided the following:

[REDACTED] stated that she had met Tyler through a friend at Posten Butte High School. At the time she was 15 years old and Tyler was 18 years old. [REDACTED] had told Tyler she was 15 years old. When they had met they started to hang out. The last time that they hung out Tyler had forced her to have sex. [REDACTED] stated she did not want to have sex and she told him "No". Throughout the incident [REDACTED] continued to tell him "No". At one point [REDACTED] attempted to push Tyler off of her however in response Tyler hit her.

[REDACTED] stated that when they would hang out it would usually be at his house. [REDACTED] identified Tyler's house as being located in [REDACTED]. While at his house [REDACTED] has only been in the downstairs and Tyler's room. [REDACTED] identifies Tyler's room using hand gestures the whereabouts of the furniture located within.

[REDACTED] stated that the first time that she and Tyler had intercourse they were at his residence in his room. It was a half day of school and they had gone to his house. The two of them went up to Tyler's room, began kissing, removed one another's clothing, and had intercourse. [REDACTED] identified intercourse as Tyler's dick entering her vagina.

[REDACTED] continues that the two of them have had intercourse approximately three times. The last time act was involuntary.

[REDACTED] states that the last time they had been together was immediately after the 2014 March spring break. She was contacted by Tyler through Snap Chat and asked if she wanted to hang out. [REDACTED] advised that she was willing to hangout but nothing more. [REDACTED] explained that she had just ended a relationship and did not want to pursuit anything other than a friendship. [REDACTED] states that during the last contact they were once again at his residence. Tyler began kissing her and touching her. [REDACTED] told Tyler to stop and attempted to push him off of her.

[REDACTED] stated that Tyler had taken her phone and moved it away from her.

[REDACTED] explains the touching as Tyler attempting to put his hands down her pants

and up her shirt.

██████ reverts back to the act of pushing Tyler and telling him "No", stating that she believes she struck him in the face while resisting. In response Tyler struck her in the stomach.

After struggling some time Tyler picked her up and carried her upstairs. ██████ states that Tyler is much stronger than she is and she could not defend herself. Tyler began forcing her pants off of her while she was resisting. Once Tyler had removed her pants he forced her. ██████ states that she did not want to do anything, he forced her.

██████ identifies her clothing as a black V-neck sweater and blue jeans, but could not positively identify Tyler's clothing.

██████ does recall that during the struggle Tyler had ripped the zipper on her pants.

██████ states that Tyler forced his dick inside her vagina while holding her hands down. There was no protection used and cum came out of his dick when he was done.

██████ states that after the incident Tyler took her home.

██████ states that after the incident she attempted to warn Tyler's current girlfriend ██████

██████ then turns her attention to her phone, indicating the last time she talked to Tyler was on 03/27/14. ██████ begins reading text messages between her and Tyler in which she makes mention of being "fucked" by Tyler. While reading the responses to the messages there is no reply of denial made by Tyler.

The interview was concluded at 1658 hours.

On 04/30/2014 at 1639 hours, I made further contact with ██████ at her residence of ██████, San Tan Valley. Our contact was audibly recorded, attached and available for review.

The following is a summary of our contact:

██████ stated that she had met Tyler through a friend at school. ██████ believes the two could have begun a relationship in January of 2014. ██████ stated that she knew he was 18 but there was never a reference in regard to his actual birthday. ██████ further states that she informed him of her age.

██████ states that all of the acts to include the sexual assault occurred during

2014.

██████ recalls returning home from springbreak on March 26th of 2014. ██████ recalls that the incident of the sexual assault occurred on 03/27/2014. This information was provided after examining her phone.

Victim: [REDACTED]

On 04/11/14 at about 1100 hrs, I conducted a forensic interview with [REDACTED] regarding a related Sexual Assault under DR #14140415135. During the interview, [REDACTED] reported that victim [REDACTED] told him that suspect Tyler Kost drove her into the desert, locked the doors, and refused to let her out unless she had sex with him. When she refused, he stated that [REDACTED] told him that Tyler drove her to the driveway of his residence and attempted to have sex with her there.

On 04/11/14 at about 1245 hrs, I attempted to interview [REDACTED] at Poston Butte High School. I learned that she had already left for the day.

On 04/15/14 at about 1248 hrs, I received a phone call from [REDACTED] friend [REDACTED]. [REDACTED] reported the following:  
About 4-5 days prior, [REDACTED] told him that she went with Tyler in his vehicle. She was under the impression that they were on their way to McDonald's to eat. Instead, Tyler drove her to a remote location, locked his doors, and refused to let her out.  
[REDACTED] asked him to contact me and request that I meet with her without her parents' knowledge.

On 04/16/14 at about 0815 hrs, I left phone messages for [REDACTED] mother [REDACTED] and father [REDACTED]

On 04/16/14 at about 0940 hrs, I received a phone call from [REDACTED] [REDACTED] reported that, about 3-4 weeks ago, [REDACTED] began acting strange as though something was wrong. [REDACTED] refused to discuss what was troubling her.

A few minutes later, I conducted a forensic interview with [REDACTED] She reported the following:

Sometime around February 2012, she shared a weight lifting class with Tyler. She won a bet with him. The wager was a meal at McDonald's. Tyler picked her up in his black pickup on a Sunday as the sun was setting. Instead of driving her to McDonald's, Tyler drove her to a remote desert area near "Little Mexico". Once there, Tyler shut the truck off, removed the ignition key, and locked the doors. Tyler laid his head on her lap and began fondling her breasts over her clothing. She told him to stop, demanded that he take her home, and tried to push him off of her. Tyler did not respond to her and kept a smirk on his face. Tyler attempted to touch her breasts under her clothing by reaching through the neck of her shirt. She struck him and demanded that he take her home. This occurred a few times. She was uncomfortable and scared. She attempted to text her friend "[REDACTED]" for help. When she did, Tyler snatched her phone from her hands. He threatened

that he would pay someone to have [REDACTED] killed if he showed up to help her. She took her phone back from Tyler and asked him what his problem was. She continued to resist and strike Tyler. Tyler drove her through the McDonald's drive-thru. He appeared frustrated and refused to speak to her. Instead of driving her home, Tyler drove her to the driveway of his residence. Once there, Tyler locked the vehicle doors and began fondling her left breast over her clothing with one of his hands. This time he left his pickup running. She told him to stop, demanded that he take her home, and tried to push him off of her. She struck Tyler when he attempted to reach through the neck of her shirt to touch her breasts under her clothing.

Tyler drove toward her home. As he drove, he texted her stating that he liked her, wanted to be with her, and wanted to have sex with her. She looked over at him. She asked him what his problem was and asked him why he was texting her instead of speaking directly to her. Tyler did not respond and appeared to be angry.

Tyler stopped in the YMCA parking lot near her home. Tyler stated that he would not take her to her house. After she got out of his pickup, Tyler accelerated quickly away from her. A few minutes later, Tyler texted her stating that he liked her and wanted to be with her.

The next day she relayed what happened to her to a group of students during her weightlifting class. [REDACTED] and [REDACTED] were three of these students. She and the group confronted Tyler. Tyler denied that the incident occurred, stating that he and she hung out just as friends. Tyler was visibly nervous and appeared guilty as though he was caught in a lie. Tyler glares at her in the hallways of their school. This makes her uncomfortable.

Last year Tyler texted and threatened to shoot her boyfriend [REDACTED] and student [REDACTED]. The two boys and [REDACTED] mother [REDACTED] may still have the text messages.

Even though he plays baseball for the school, Tyler does not have any friends and has always been creepy and weird.

I informed [REDACTED] about her mother's concern over her depression 3-4 weeks ago. She stated that she was depressed during that time as a result of the deaths of a family member and a friend and from general family problems.

On 04/16/14 at about 1105 hrs, I conducted a forensic interview with [REDACTED] He reported the following:

He shared a history and weight lifting class with Tyler. Tyler was very chauvinistic and rude. He was very disliked by everyone he met. He always butted into other people's conversations. Tyler always treated girls like trash. He was alarmed by the reports he has heard about things he has done to girls. Because of this, he strongly dislikes Tyler and goes out of his way to avoid him.

Although he did not recall seeing the text messages Tyler sent to [REDACTED] he

did remember confronting Tyler during weight lifting class. He and others confronted Tyler after ██████ told them what he had done. Tyler denied that the incident occurred. When they confronted him, Tyler's face looked "pretty damned guilty." He could not recall who else was in the group that confronted him.

██████ and Tyler were not dating during this time because ██████ and ██████ were working on a relationship.

His girlfriend told him that Tyler assaulted student ██████. She told him that ██████ wore long sleeve shirts to cover the bruises she received from Tyler.
