1 8. At all relevant times, Defendant PLANNED PARENTHOOD and DOES
2 1 through 25, inclusive, were agents and employees, each of the other, and in
3 doing the things hereinafter mentioned were acting within the scope of their
4 authority as such agents and employees and with the consent of their Co-
5 Defendants.

6 9. Plaintiff retained the services of Defendant PLANNED PARENTHOOD
7 to perform a pregnancy termination procedure on July 19, 2012. While at the
8 facility, Defendant PLANNED PARENTHOOD and its staff members violated
9 provisions of the Health Insurance Portability and Accountability Act (HIPPA) by
10 communicating to a third party that Plaintiff was at the facility for the purpose of
11 undergoing pregnancy termination.

12 10. As a result of the negligence on the part of Defendant PLANNED
13 PARENTHOOD and its staff member and violation of HIPPA provisions, Plaintiff
14 suffered embarrassment, humiliation and other emotional injuries resulting from
15 the disclosure.

16 11. Defendant PLANNED PARENTHOOD and DOES 1 through 25,
17 inclusive, carelessly, negligently and in violation of HIPPA, disclosed personal and
18 sensitive information and by doing so failed to conform to the standards of care
19 required of them as medical practitioners and facility staff members and that by
20 reason thereof, Plaintiff was caused to and did suffer irreparable, serious emotional
21 injuries and damages as described hereinabove.

22 12. As a direct result of said negligence and violation of HIPPA on the part
23 of Defendant PLANNED PARENTHOOD and DOES 1 through 25, inclusive, as
24 aforesaid, Plaintiff has suffered serious, debilitating and permanent emotional
25 injuries. Plaintiff suffers and continues to suffer mental pain, all to her general
26 damage in a sum in excess of the jurisdictional minimum of this Court. Plaintiff
27 will seek leave of court to insert said sum when known to him or upon proof
28 thereof at the time of trial.

1 13. As a further result of said acts of Defendant PLANNED PARENTHOOD
2 and DOES 1 through 25, inclusive, Plaintiff has incurred and will continue to incur
3 medical and related expenses, as well as lost earnings, the full amount of which
4 has not been ascertained by Plaintiff at this time. Plaintiff will amend this
5 Complaint to state the true and exact amount of said expenses and losses when
6 the same becomes known to her or upon proof thereof at the time of trial.

7
8 WHEREFORE, Plaintiff EBONY SIMPSON prays for judgment against the
9 Defendants, and each of them, as follows:

- 10 1. For economic and noneconomic damages according to proof, but in an
11 amount over and above the minimum jurisdictional amount of the Superior Court
12 of the State of California;
- 13 2. For costs of suit incurred herein; and
- 14 3. For such other and further relief as the Court deems just and proper.


