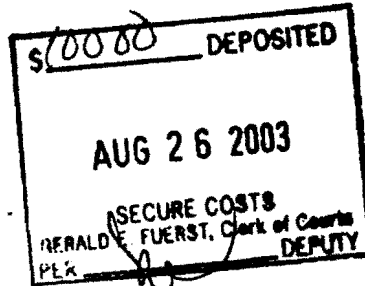

Now comes the Plaintiffs, by and through counsel, and for their Complaint against the Defendants states as follows:

1. Defendant, Lakewood Hospital, is and was, at all times relevant, a corporation duly organized under the laws of Ohio, which held itself out to the public, including the Plaintiffs herein, as competent and qualified to provide safe and adequate hospital and medical care and treatment.

2. Defendants, Premier Physicians Centers, Inc. and Planned Parenthood of Greater Cleveland, Inc., are and were at all times relevant corporations organized under the laws of Ohio, which held themselves out to the public, including the Plaintiffs herein as competent and qualified to provide safe and adequate medical and surgical care.

3. Defendants, Ronald S. Garcia, M.D., Perlita McGuinness, M.D., Adnan Raed, M.D. and Brian F. McNamee, M.D., are and were at all times herein relevant, licensed physicians who held themselves out to the public, including the Plaintiff herein, as a competent and qualified to provide safe and adequate medical care and treatment.

4. Beginning on or about August, 1997 and ending on or about April 1, 2002,

Plaintiff, Sabrina D. Leach was under the care and treatment of the Defendants.

5. By reason of the negligent acts and/or omissions of the Defendants, including the failure to provide adequate information as to the risks of said procedure upon which Plaintiff, Sabrina Leach could give informed consent, and as a direct and proximate result thereof, Plaintiff, Sabrina Leach, sustained severe and permanent injuries.

6. Said injuries caused pain, suffering and disability, still cause pain, suffering and disability, and will continue to cause pain, suffering and disability in the indefinite future.

7. By reason of this substandard care, Plaintiff, Sabrina Leach lost earnings and, in all probability, will lose future earnings. Plaintiff's future earning capacity has been impaired.

8. As a result of the substandard care, Plaintiff, Sabrina Leach necessitated medical care and treatment and expects to necessitate additional medical care and treatment in the indefinite future.

9. Plaintiff, Sabrina Leach has incurred medical expenses and expects to incur additional medical expenses in the indefinite future.

THEREFORE, Plaintiff, Sabrina Leach demands judgment against the Defendants, jointly and/or severally and/or concurrently in an amount in excess of Twenty Five Thousand Dollars (\$25,000.00) and costs of the instant action.

COUNT II

10. Plaintiff, Scott Leach, incorporates herein by reference all of the facts and statements contained in Count I, as if fully rewritten herein, and says further that he is and was at all times herein mentioned the husband of Plaintiff, Sabrina D. Leach.



Defendant, Planned Parenthood of Greater Cleveland, Inc. ("Defendant") for its Answer to the Plaintiffs' Complaint makes the following admissions, denials, statements and defenses.

FIRST DEFENSE

1. Defendant is without knowledge sufficient to form a belief as to the truth of the allegations set forth in Paragraphs 1 and 3 of Plaintiffs' Complaint.

2. Defendant admits its corporate status and that it held itself out to the public, including Plaintiff Sabrina D. Leach (known by it only as Sabrina Peskie) as competent and qualified to provide safe and adequate reproductive health care services; Defendant denies the remaining allegations of Paragraph 2 of Plaintiffs' Complaint that relate to it and states that it is without sufficient knowledge to form a belief as to the truth of the remaining allegations set forth in Paragraph 2 of Plaintiffs' Complaint.

3. Defendant admits that from time to time Plaintiff Sabrina Leach received professional services from it but denies the allegations set forth in Paragraph 4 of Plaintiffs' Complaint that relate to it. Defendant is without sufficient knowledge to form a belief as to the truth of the remaining allegations set forth in Paragraph 4 of Plaintiffs' Complaint.

4. Defendant denies the allegations set forth in Paragraph 5 of Plaintiffs' Complaint that relate to it. Defendant is without sufficient knowledge to form a belief as to the truth of the remaining allegations set forth in Paragraph 5 of Plaintiffs' Complaint.

5. Defendant denies the allegations set forth in Paragraphs 6, 7, 8, 9 and 11 of Plaintiffs' Complaint.

6. Defendant in response to Paragraph 10 of Plaintiffs' Complaint repeats and realleges each of its foregoing admissions, denials and statements and denies the remaining allegations thereof.

7. Defendant denies each and every allegation, including all demands and/or prayers for relief, not herein specifically admitted to be true.

AFFIRMATIVE DEFENSES

8. Plaintiffs' Complaint fails to state a claim, in whole or in part, upon which relief may be granted.

9. Plaintiffs' claims are barred, in whole or in part, by the applicable statute of limitations.

10. Plaintiffs' alleged injuries and damages were caused by acts or omissions of others whose conduct was not under the control or direction of this Defendant and for whose conduct this Defendant cannot be held responsible or liable.

11. Plaintiffs' alleged injuries and damages were proximately caused by or were the result of intervening and/or superceding actions and/or omissions over which this Defendant had no control or right of control, and for which this Defendant is neither responsible nor liable.

12. The care provided Plaintiff Sabrina D. Leach by this Defendant was in conformity with all applicable standards of care at all times.

13. Plaintiffs' alleged injuries and damages were caused, or contributed to, by Plaintiffs' own negligence in an amount that was equal to or greater than the alleged negligence of Defendant, which negligence is specifically denied.

14. Defendant is entitled to a setoff of damages and/or limitations of damages pursuant to law.

15. Plaintiffs have failed to join all parties necessary for just adjudication pursuant to Rules 19 and 19.1 of the Ohio Rules of Civil Procedure and/or have failed to pursue all or part of this action in the proper forum.

16. Plaintiff Sabrina Leach assumed the risks of all alleged injuries and damages complained of in her Complaint.

17. Plaintiff was fully advised of the risks that were clearly inherent in her situation and she assumed those risks.


18. Any acts or omissions by Defendant were not the direct and proximate cause of alleged injuries or damages of Plaintiff Sabrina D. Leach.

19. Defendant reserves the right to amend this Answer to assert additional affirmative defenses as they become known through discovery.

WHEREFORE, Defendant prays that Plaintiffs' Complaint be dismissed and that it go hence without day and recover its costs herein expended.
