
Now comes the Plaintiff, Lynn McKee, by and through counsel, and for her complaint against defendants states the following:

1. Defendant Jane Doe, at all times material herein was a licensed member of the medical profession of the State of Ohio, and was a practicing physician, physician's assistant and/or nurse employed by Planned Parenthood of Greater Cleveland.
2. Plaintiff on or about June 10, 2001, went to Planned Parenthood of Greater Cleveland located at 1835 Forest Hills Blvd., East Cleveland, Ohio, where Defendant Planned Parenthood and/or Jane Doe, and/or their employees negligently administered an injection to Plaintiff.

3. As a result of said negligence, Plaintiff suffered a spontaneous abortion and suffered bodily injuries including pain and suffering and emotional distress preventing her from engaging in certain activities. 
